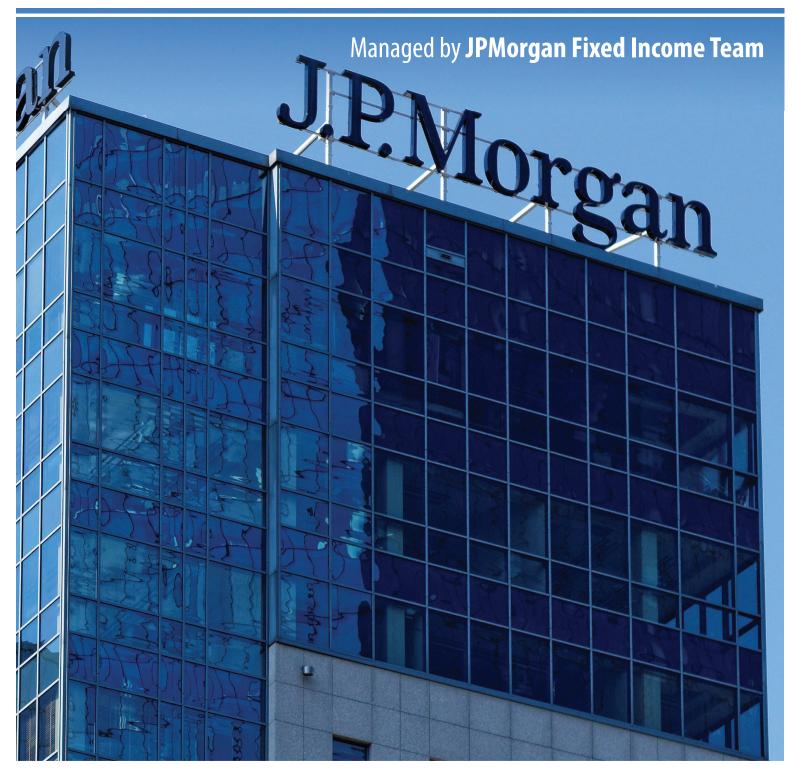

HIGH YIELD STRATEGY

J.P.Morgan Asset Management's High Yield strategy utilizes fundamental, bottom-up research with a disciplined security selection process which seeks to consistently generate superior risk-adjusted returns. Proprietary fundamental research, a disciplined approach to relative value, and risk management drive the investment process which results in a well-diversified, optimally constructed portfolio.

INVESTMENT PROCESS

Fundamental Analysis

The fundamental research process combines the expertise of High Yield Credit Analysts with the strength of the broader J.P.Morgan fixed income team. Industry specialists develop in-depth knowledge of the companies in their focus area through qualitative research, and combine analysis of historical financial performance with the current market environment to prepare financial projections.

We believe capitalizing on changing fundamentals before the broader marketplace results in superior risk-adjusted returns over time.

Security Valuation

The disciplined security selection process seeks to find the most attractive investments within each market sector. Dedicated High Yield Analysts evaluate and compare individual securities within a sector and within a company's capital structure to find the most attractive opportunities.

RISK MANAGEMENT

Risk management is a core component of the High Yield fixed income investment process. Unlike many other High Yield Corporate Bond Funds, Integrity High Income Fund is broadly diversified. With over 600* positions and in conjunction with JPMorgan research resources, the Fund allows for diversification between many different securities and also allows for diversification between various sectors. This provides the investor with an instant degree of diversification upon purchase of the Fund. Diversification allows investors to reduce the risk of one particular security or sector, and also allows for a broader exposure to various securities and sectors.

Portfolio Managers are also trained in credit analysis and utilize their experience to ensure the credits are scrutinized from all angles and that the right questions are asked. This intensive approach to the credit market drives superior security selection and helps us to maintain the appropriate vigilance in the ongoing monitoring of credit risk within the portfolio.
